#### ONE:

Despite the driest year on record, our group has planted 100 indigenous shrubs and grasses along the water course, to compliment already 4,500 trees and shrubs planted since September 2002.

Our weed control around the northern dam and associated fence line is at a level better than ever achieved at this time of year.

The group's members have received training in Brush Cutter Safety & Operation as well as chemical handling.

#### **THREE**

The Friends are very appreciative to the University for the authority to use the 2 car garage on the eastern hill adjacent to the manager's residence.

At this stage we plan to use this garage to house our equipment trailer, once the security work is completed and use it for shelter when winter weather is extreme.

We also now have access to the toilets located in Building 23 and accept the cleaning responsibility.

# **Current Progress of our work at**

# **GLENTHORNE FARM**

#### TWO:

Our group is keen to work with The University's Jennifer Gardner and the SA Urban Forests to protect the remnant Grey Box (Eucalyptus Microcarpa) trees located on the eastern side of the property along South Road.

All parties agree that this is the area of highest priority for the property, as these trees have significant heritage and biodiversity value. Our Chairman is currently contacting Jennifer Gardner to further pursue this matter.

Friends of Glenthorne will apply for funding to fence and protect these important trees which are being damaged by sheep which eat the lower foliage, trample the ground around the trunks and concentrate defecation in the near vicinity.

#### FOUR

In the nearly 6 years of control by the University of Adelaide, since approximately June 2001, no progress has been made in the protection of the heritage buildings.

Despite The University of Adelaide having 'panels of advisors to assist in any determination regarding heritage buildings", the buildings have suffered from weather exposure and damage from massive olive trees that are growing right through these fragile structures.

These buildings date back to the 1840's when Captain O'Halloran and his family lived at Glenthorne farm, known then as Lizard Lodge.

In Pam Smith's 'Historic sites and landscaped - The Southern Hills Volume IV' booklet from 2005, the archaeologist from Flinders

University says "It is strongly recommended that the existing nineteenth century buildings be restored and interpretive signs erected. If work does not start soon, there will be nothing left to restore.

#### **FIVE**


Kym Richardson, MP Federal Member for Kingston announced Friends of Glenthorne had been successful in its application of the 'Volunteer Small Equipment' Grant.

## **Historical Background**

A condensed chronology of the Glenthorne property, which falls under the parent title of CT 4129/765 (Volume 5377, Folio 7) is given below.

- 1839: Major O'Halloran arrives with his wife and two sons on the Rajasthan to take up his land grant.
- 1839: O'Halloran family moves into Lizard Lodge, ten miles from Adelaide.
- 1840: O'Halloran appointed Major Commandant of the South Australian Militia and Commissioner of Peace.
- 1842: O'Halloran resigns his positions and enters the Legislative Council.
- 1870: O'Halloran dies at the age of 83
- 1878: O'Halloran estate purchased by Thomas Porter, who renamed the estate Glenthorne.
- 1879: Construction of Glenthorne House
- 1903: Estate purchased by George Brookman, MLC.
- 1910: Estate purchased by Harold Charles Drew.
- 1913: Glenthorne compulsorily acquired by the Commonwealth and established as No. 9 Remount Station.
- 1932: Glenthorne House gutted by fire and remains are razed by military engineers who leave little evidence of the original house.
- 1947: CSiRO (then CSIR) acquires the property to establish the Glenthorne Field Station.
- 1997: Glenthorne purchased by University of Adelaide.
